**CANDIDATES SEEKING THE SEAT OF MAYOR SHALL RESIDE ON ANY OF THE SAID ISLANDS OF THE VILLAGE FOR A PERIOD OF NOT LESS THAN ONE (1) YEAR PRIOR TO THE INITIAL DATE OF FILING OF QUALIFYING PAPERS. THE CANDIDATE ELECTED TO OFFICE MUST BE AND SHALL REMAIN A PERMANENT RESIDENT OF THE VILLAGE FOR THE DURATION OF THE TERM OF OFFICE.**

**CANDIDATES SEEKING THE SEAT OF NORTH BAY ISLAND COMMISSIONER MUST BE A RESIDENT OF NORTH BAY ISLAND FOR A PERIOD OF NOT LESS THAN ONE (1) YEAR PRIOR TO THE INITIAL DATE OF FILING OF QUALIFYING PAPERS.
