The event hours are 8:00am–2:00pm, Saturday, November 21<sup>st</sup>. Check-In starts at 7:00am at Trio on the Bay 1601 79<sup>th</sup> Street Causeway, North Bay Village, FL 33141 (Treasure Island)

Setup begins at 7:00am. Setup must be completed by 8:00am and **ALL vehicles must** be out of the front entrance. Please be sure to bring any tables, dollies and carts, etc. you may need. You must unload your vehicle immediately upon arrival and find your space. Once your items are unloaded, you must move your vehicle.

Yard Sale ends at 2:00pm. You will not be permitted to bring your vehicle into the event area until the end of the event. You must be cleared of your vendor space by 2:30pm. Under **NO** circumstances items can be left onsite. You must leave the location clean of trash and debris.

North Bay Village events are family oriented. We will not permit vendors to sell items that are vulgar, offensive, or obscene. All merchandise must be acceptable for children under the age of 18 to view. Any vendor and/or their volunteers using vulgar or obscene language or wearing articles of clothing with vulgar pictures or wording will be asked to leave and the vendor will be removed from our vendor list for future events.

Alcoholic beverages and smoking are **not** permitted in the event area at any time.

You must bring your own money and enough change for your sales. The Village will not have any cash available for change.

Vendor items **MUST** remain in designated space; this includes display racks, tables, etc. Vendors must supply their own tents, tables, chairs, etc. **Tents cannot be staked. They must be free standing with weights.**

- 94.020(A)(3)3. Expanded polystyrene food service article means plates, bowls, cups, containers, lids, trays, coolers, ice chests, and all similar articles that consist of Expanded Polystyrene (Styrofoam).
- 94.020 (B) Village contractors shall not sell, use, provide food in, or offer the use of Expanded Polystyrene Food Service articles in Village facilities or on Village property. A violation of this section shall be deemed a default under the terms of the Village contract, lease, or concession agreement. This subsection shall not apply to Expanded Polystyrene Food Service Articles used for prepackaged food that have been filled and sealed prior to receipt by the Village Contractor.
- § 97.04(13) It shall be unlawful for any person to use, carry, place or discard any Expanded Polystyrene (as defined in Section 94-03 of the Village Code) product into any park within the Village
